


LOWER CEDAR WATERSHED MANAGEMENT AUTHORITY BOARD OF DIRECTORS

Meeting Minutes for Tuesday, August 8, 2023, 6:30 pm West Branch Old Town Hall, 113 N. 1st Street, West Branch

- 1. Call to Order: Meeting called to order by Chairperson Jon Bell at 6:32 pm
- 2. Roll Call
- 3. Approve Minutes from May 9, 2023, Board Meeting
 - Motion by Furnas, second Schroeder. All Ayes. Motion carried.
- 4. Treasurer's Report by Waldie
 - Financial Statement w/ receivable & expenditure balances. Net Balance approximately \$43,700. Motion to approve the Treasurer's Report by Smith, seconded by Furnas. All Ayes. Motion carried.
 - Heartland Co-op requests to go to quarterly invoicing. Motion to approve quarterly invoicing by Schroeder, second by Spevacek. All Ayes. Motion carried.
 - FY24 Budget / Invoices Bill sending invoices as members finalize their amounts.
- 5. Lower Cedar Conservation Outreach Update Davis, Heartland CO-OP, gave an update to the project (report attached). There is a Field Day planned for June 6th at Kent Faucett's farm to highlight saturated buffers and prairie strips. Another Field Day is planned for August 22nd. The Batch & Build effort has lined up 39 projects with 12 to 15 farmers to install saturated buffers and bioreactors. Davis will ask Johnson County to assist with bidding the project construction.
- 6. Letter of support for TNC's "Lower Cedar Floodplain Easements" grant application to the RCPP. Motion by Waldie to authorize the Chair to sign the letter committing technical assistance valued at \$25,000 as inkind support over the 5 year project to coordinate with WMA partners and assist with outreach efforts, seconded by Schroeder. All Ayes. Motion carried.
- 7. Indian Creek Soil Health Partnership Update working on the grant contract amendment and filling the vacant Soil Health Coordinator position.
- 8. Outreach
 - Krouse gave an update on the citizen-led water sampling project in Mt. Vernon to increase water quality awareness. Samples are collected the 3rd Saturday each month and there has been strong resident support.
- 9. Member Updates & Announcements Kate Giannini with the Iowa Flood Center reported that their project to expand water monitoring and weather stations in the Lower Cedar Watershed.
- 10. Next Meeting: August 8, 2023 @ 6:30 PM (Location TBD)
- 11. Meeting was adjourned at 7:40 pm. Motion by Waldie, second by Spevacek, All Ayes. Motion carried.



- Iowa continues to be very dry.
 - Spring 2023 was a tough spring for cover crop users- very dry conditions did not offer much forgiveness in cover crop fields. I'm seeing more hesitancy to continue use or try it for the first time.
- Farmers are making cover crop plans for fall- Airplanes will begin applying cover crops in late-August-September

Cover Crop enrollment started in June. To date, 13 farmers have enrolled over 6,800 acres in the cover crop program for this fall during the early sign up period. A great start for this early in the year! Enrollment goes through December 1st,2023.
